The stewards received a report from the FIA Technical Delegate concerning competitor No. 73 stating as follows:

RZ8 After SS9:

- Competitor n°73 was refuelling his car inside the FIA Refuelling area
- Competitor n°73 did NOT take fuel provided by the FIA appointed supplier.
- Competitor n°73 did NOT take fuel from pumps available at the petrol station
- Crew of competitor n°73 brought fuel drum and competitor was using fuel from this drum to refuel his car

In addition:

- Competitor n°73 opened the bonnet of his car inside the FIA refuelling area
- Competitor n°73 filled some water in the engine compartment inside the refuelling area

The Stewards also received confirmation from the FIA Technical Delegate that the fuel analysis of the fuel samples subsequently taken from car No. 73 is a commercial fuel (not a competition fuel).

The stewards then summoned the crew of car No. 73 to them to be heard at 19.45 hrs the same evening.

The crew appeared in front of the Stewards at 20.00 hrs.

During the hearing, the crew stated that they used fuel taken at the filling station indicated in the Road Book not directly dispensed from the pump but using their own filling equipment.

Furthermore, they admitted having opened the bonnet and having used some water in order to cool down the turbocharger.

It was also clarified that the crew had opened the bonnet thus breaching Article 58.2.1 of the 2012 FIA WRC Sporting Regulations.

The Stewards, after due deliberation, concluded that the crew used commercial pump fuel available and dispensed from the pump at the filling station and RZ marked in the Road Book and

Handwritten signatures and initials at the bottom right of the page.
